## Southern Cross Care (Tas) Yaraandoo

Workload Issues - Update

The Australian Nursing and Midwifery Federation Tasmanian Branch (ANMF) have formally raised the following workload concerns with Southern Cross Care (Tas) (SCCT) management on behalf of our members.

- Current rostering after hours of 1 Registered Nurse (RN) and 1 Enrolled Nurse (EN) for 52 patients is unsafe.
- The requirement to answer the doorbell, phone and assess all persons on entry to the facility due to COVID-19 places further demands on the RN in charge, particularly on morning and afternoon shifts.
- Recent directive for nurses to complete care plans throughout their shift along with the perceived threat to 'expect consequences' if not completed has left nurses feeling intimidated.
- Nurses regularly are required to stay late to complete all necessary documentation.
- Recent experiences of nurses being called to answer allegations that have not been properly investigated is perceived as judgemental, accusatory in nature without established facts and procedurally unfair.
- Nurses feel that their time management and clinical skills are being questioned, leaving them unable to raise concerns in a constructive collaborative way.
- RNs who work in charge shifts feel undervalued and misunderstood by management with regards to the amount of time that is required to manage not just the clinical load, but all the other things that arise such as patient falls, unstable palliative patients, incomplete admission paperwork, responding to phone enquiries about residents, replacement of staff and reallocation when Extended Care Assistants (ECAs) are short staffed.

The ANMF offered to meet with SCCT management to address the above concerns, however the offer was not accepted and a most unsatisfactory response was received. The ANMF are now of the view that SCCT does not want to engage collaboratively on these matters and we are left with limited avenues to resolve our members' concerns. The ANMF have further requested an onsite meeting to resolve the issues. In the alternative, if SCCT continues to maintain that there are not workload issues at Yaraandoo and refuse to meet and be collaborative to resolve these concerns, then the ANMF will be preparing a complaint to the Aged Care Quality and Safety Commission.
