Member Meeting Update - Wednesday 21 May 2025

The Australian Nursing and Midwifery Federation Tasmanian Branch (ANMF) would like to thank all members who attended the recent meeting on Wednesday 21 May 2025 to discuss the benchmarking proposal and other ongoing issues on K9East.

We acknowledge and apologise for any concern caused by the previous newsflash regarding the benchmarking proposal. The ANMF was seeking confirmation from Tasmanian Health Service (THS) management regarding the issues raised. THS has confirmed Nurse Practitioner (NP), Clinical Nurse Consultant (CNC) and Clinical Nurse Specialist (CNS) roles provide organisational services and they will continue to do so.

Benchmarking Proposal - Member Vote Required

At the meeting, The ANMF confirmed that the designation of clinical coaches remains an ongoing matter for discussion. However, members agreed that this issue should not delay urgently needed staffing increases to support your roles. The current benchmarking proposal is to add 4 Assistants in Nursing (AINs), 7 days a week, to the K9East roster.

Also discussed was the current rostering of Enrolled Nurses (ENs). The ANMF reminds members that under the *Nurses and Midwives (Tasmanian State Service) 2023*, ENs should not exceed 30% of the roster.

The ANMF updated members on consumable concerns raised through recent surveys. Three formal letters have been submitted to executives based on your feedback. The ANMF's Acting Branch Secretary has also raised the issue with the Health Minister, specifically requesting the removal of approval requirements for the top five consumables identified by members. We are awaiting a formal response and will share it once received.
