Lodging Nominations

Nominations open on 01/07/2024 and must reach the Returning Officer, Hanish Gupta not later than 12:00 Noon Australian Eastern Standard Time (AEST) on 15/07/2024.

Nominations cannot be withdrawn after 12:00 Noon Australian Eastern Standard Time (AEST) on 22/07/2024.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Candidate Statements

Only statements which comply with the Rules and are received by the Returning Officer by 5:00 pm (Australian Eastern Standard Time (AEST)) on 22/07/2024 can be accepted.
