WHAT IS A MOTION?

A motion is a formal proposal to be made by a Workplace Delegate, who is attending the conference, asking the ANMF (Tas Branch) to take action of some kind. Decisions are made at the conference discussing, debating and agreeing to a motion – it then becomes a Resolution of the conference.

Motions should be a matter that relates to members of the ANMF (Tas Branch) and aligns with the Branch's Mission Statement of representing, advancing and empowering nurses, midwives and care workers through leadership, advocacy and active participation in industrial, professional and political issues that influence the lives of our members and the important services they provide to the Tasmanian community.

In order for a motion to be considered, the Workplace Delegate must move the motion and another Workplace Delegate must second it. The conference chair then puts the motion to the conference and a vote on the motion is conducted. If the motion is carried, the Resolution is presented to ANMF (Tas) Branch Council for ratification and implementation and becomes part of our union's future work and strategy.

EXAMPLE: 2023 RESOLUTION

RESOLUTION: That the ANMF (Tasmanian Branch) immediately lobbies the State Government/THS and private health providers to provide personal duress (alarm) lanyards for nurses who wish to wear one for personal safety.

BACKGROUND: Presently, personal duress lanyards are available in some wards (e.g., Psych, ED), but not all. Increasingly nurses and midwives in all areas of health are facing situations where patients or clients are being verbally or physically threatening. In some of these scenarios nurses and midwives can be physically trapped and unable to escape or call for help. Access to a duress lanyard would enable nurses and midwives to immediately call for assistance and lessen the chance of physical harm or psychological trauma.
